- The official House bank account is currently with KECU (Kentucky Employee's Credit Union). This location is temporary, however. A permanent institution will be selected at a future date.

NEW BUSINESS

- A mentor for the KFS has been appointed. Everyone give a big KFS hug to Sister Beatrix Uppersleeve of the Russian River Sisters!
- Bylaws
 - o A rough draft of the KFS bylaws has been reviewed and revised. Further revisions will need to be done.
 - Once the second revision is complete, the full House will vote on them online via a poll that will be created.
- Potential Novice Projects
 - o In order for the KFS to reach fully professed status, House membership will need to complete a minimum of six (6) novice projects.
 - o Corey Bowling discussed doing a "Talk Sex with the Sisters" series that would be modeled after the television show "Talk Sex with Sue". This series will involve

- the drafting and distribution of approximately five or six pamphlets that outline such topics as safe sex tips and resources to the community. Ray Shields motioned to adopt this project, Jared Hubbard seconded the motion. Corey's project was unanimously accepted.
- o Jared Hubbard discussed holding a monthly social gathering/board game night. In order to help generate House funds, tickets could be purchased for a small price. The winners of each game played will receive some sort of prize. Possible locations for these events were: West Sixth Brewery, PCSO, Unitarian Universalist Church in Frankfort and Lexington, and Lexington Public Library. - A House Finance Committee was created. The members of the Committee are John Hager, Jesse Ruble, Jared Hubbard, and Ray Shields.
